You are required to submit a technical proposal and a financial proposal using the format provided in the Request for proposals (RFP) document. The detailed requirements for the proposals are contained in **Section II: General Information to Consultants** and **Section III: Terms of Reference**. You are advised to read the two sections carefully before compiling your proposals.

Each proposal must be submitted in two copies one marked “**ORIGINAL**” and the other marked “**COPY**”. The two copies of the proposal shall be submitted in plain sealed envelopes marked either “Technical Proposal” or “Financial Proposal” as applicable. The two envelopes shall be placed inside an outer envelope marked “**RFP NO. KAS/RFP/MSR/009/2018/2019: Proposals for provision of consultancy services for collection of stakeholders’ views on the major syllabuses review**” and addressed to:

GENERAL INFORMATION TO CONSULTANTS (GITC)

2.1 Introduction

2.1.1 The request for proposals (RFP) includes the following documents:

2.1.2 kasneb will select a firm from among those invited to submit a proposal, in accordance with the method of selection detailed in **Appendix A**.

2.1.3 The Consultants are invited to submit a Technical Proposal and a Financial Proposal as specified in **Appendix A** for consulting services required for the assignment named in Appendix A.

2.1.4 The Consultants may familiarise themselves with the operations and strategic plan of kasneb before preparing their proposals. To obtain first hand information on the assignment, Consultants are encouraged to liaise with kasneb regarding any information that they may require before submitting a proposal. Consultants should contact the official named in **Appendix A** for any clarification. Consultants may also find it useful to visit kasneb's website at www.kasneb.or.ke

2.1.5 kasneb will provide the inputs specified in **Appendix A**, and make available relevant project data and documents.

2.2 Clarification and Amendment of RFP Documents

2.2.2 Consultants may request a clarification of any of the RFP documents only up to seven [7] days before the proposal submission date. Any request for clarification must be sent in writing by paper mail or by electronic mail to the Client's address indicated in **Appendix A**. kasneb will respond in writing by paper mail or electronic mail to such requests and will send written copies of the response (including an explanation of the query but without identifying the source of inquiry) to all Consultants invited to submit proposals.

2.2.3 At any time before the closing date of proposals submission, kasneb may, for any reason, whether at its own initiative or in response to a clarification requested by an invited firm, amend the RFP. Any amendment shall be issued in writing through an Addendum. The Addendum shall be sent by paper mail or by electronic mail to all invited Consultants and will be binding on them. kasneb may at its own discretion extend the deadline for the submission of proposals.

2.3 Preparation of Technical Proposal

- 2.3.1 The Consultants' proposals shall be written in the English language.
- 2.3.2 In preparing the Technical Proposal, Consultants are expected to examine the documents constituting this RFP in detail. Material deficiencies in providing the information requested may result in the rejection of a proposal.
- 2.3.3 While preparing the Technical Proposal, Consultants must give particular attention to the following:
- (i) If a firm considers that it does not have all the expertise for the assignment, it may obtain a full range of expertise by associating with individual Consultant(s) and/or other firms or entities in a joint venture or sub-consultancy as appropriate. Consultants shall not associate with the other Consultants invited for this assignment. Any firms associating in contravention of this requirement shall automatically be disqualified.
 - (ii) The proposal shall be based on the number of professional staff-time estimated by the firm.
 - (iii) It is desirable that the majority of the key professional staff proposed for this assignment be either permanent employees of the firm or have an extended and stable working relationship with it.
 - (iv) Proposed professional staff must, as a minimum, have the experience indicated in **Appendix B**.
 - (v) Alternative professional staff shall not be proposed and only one Curriculum Vitae (CV) may be submitted for each position.
- 2.3.4 The Technical Proposal shall provide the following information using the attached Standard Forms;
- (i) A brief description of the firm and an outline of recent experience in assignments of a similar nature (minimum of 3). For each assignment the outline should indicate *inter alia*, name of the firm, the duration of the assignment, the contract amount and the firm's involvement.
 - (ii) Any comments or suggestions on the Terms of Reference, a list of services and facilities to be provided by the Client.
 - (iii) A detailed description of the methodology and work plan proposed by the Consultant, as well as staffing.
 - (iv) The list of the proposed team members by specialty, the tasks that would be assigned to each staff team member and their timing.
 - (v) CVs recently signed by the proposed professional staff and the authorised representative submitting the proposal. Key information should include number of years worked for the firm/entity and degree of responsibility held in various assignments during the last (5) years.

- (vi) Estimates of the total staff input (professional and support staff staff-time) needed to carry out the assignment supported by Gantt chart(s) or by bar chart diagrams showing the time proposed for each professional staff team member.
- (vii) Any additional information requested in **Appendix A**.

2.3.5 The Technical Proposal shall **not** include any financial information.

2.4 Preparation of Financial Proposal

- 2.4.1 In preparing the Financial Proposal, Consultants are expected to take into account the requirements and conditions outlined in the RFP documents. The Financial Proposal should follow Standard Forms (**Appendix C**). It lists all costs associated with the assignment.
- 2.4.2 The Financial Proposal should include all applicable taxes and levies.
- 2.4.3 Consultants shall express the price of their services in Kenya Shillings.
- 2.4.4 The Proposal must remain valid for 90 days after the submissions' closing date. During this period, the Consultant is expected to keep available, at his own cost, the professional staff proposed for the assignment. kasneb will make its best effort to complete evaluation, contract award and negotiations processes within this period. If kasneb wishes to extend the validity period of the proposals, the Consultant shall agree to the extension.

2.5 Mandatory requirements

Consultants are required to submit copies of the following mandatory documents together with their technical proposals:

- (i) Certificate of Registration/Incorporation as applicable.
- (ii) Valid Tax Compliance Certificate from Kenya Revenue Authority.
- (iii) Completed anti-corruption declaration form.
- (iv) Confidential Business Questionnaire dully filled and stamped.
- (v) CR 12 form from Registrar of Companies.

2.6 Submission, Receipt and Opening of Proposals

- 2.6.1 The original Technical and Financial Proposals shall be prepared in indelible ink. They shall contain no interlineations or overwriting, except as necessary to correct errors made by the firm itself. Any such corrections must be initialled by the person(s) authorised to sign the proposals.
- 2.6.1 For each proposal, the Consultants shall prepare the number of copies indicated in **Appendix A**. Each Technical Proposal and Financial Proposal shall be marked "**ORIGINAL**" or "**COPY**" as appropriate. If there are any discrepancies between the original and the copies of the proposal, the original shall govern.
- 2.6.2 The original and the copy of the Technical Proposal shall be placed in a plain sealed envelope clearly marked "**TECHNICAL PROPOSAL**," and the original and the copy of the Financial Proposal shall be placed in a plain sealed envelope clearly marked "**FINANCIAL PROPOSAL**." Both envelopes shall be placed inside

an outer plain envelope and sealed. This outer envelope shall bear **only** the Proposal number, name and the submission address.

2.6.3 The completed Technical and Financial Proposals must be delivered at the submission address on or before the closing date and time stated in **Appendix A**. Any proposal received after the closing time for submission of proposals shall be returned to the respective Consultant unopened.

2.6.4 After the deadline for submission of proposals, the Technical Proposal shall be opened immediately by the Opening Committee. The Financial Proposal shall remain sealed and deposited with a responsible officer of kasneb up to the time for opening of financial proposals.

2.7 Proposal Evaluation General

2.7.1 From the time the bids are opened to the time the Contract is awarded, if any Consultant wishes to contact kasneb on any matter related to his proposal, he should do so in writing at the address indicated in **Appendix A**. Any effort by the firm to influence kasneb in the proposal evaluation, proposal comparison or Contract award decisions will result in the rejection of the Consultant's proposal.

2.7.2 Evaluators of Technical Proposals shall have no access to the Financial Proposals until the technical evaluation is concluded.

2.8 Evaluation of Tenders

2.8.1 The Evaluation Committee appointed by kasneb will undertake preliminary examination of the proposals to determine their responsiveness to the mandatory requirements. The firms that will not be responsive to the mandatory requirements will be disqualified from any further evaluation at this stage.

2.8.2 The Evaluation Committee will evaluate the technical proposals which were responsive to the mandatory requirements on the basis of their responsiveness to the Terms of Reference, applying the evaluation criteria as follows:

A proposal shall be rejected at this stage if it does not respond to important aspects of the Terms of Reference or if it fails to achieve the minimum technical score indicated in **Appendix A**.

2.9 Opening and Evaluation of Financial Proposal

2.9.1 After the evaluation of the Technical Proposals, kasneb shall disqualify the proposals that did not meet the minimum qualifying mark or were considered non-responsive to the RFP and Terms of Reference, from any further evaluation. kasneb shall thereafter open and evaluate the financial proposals.

2.9.2 The Evaluation Committee will determine whether the financial proposals are complete (that is whether the Consultant has costed all the items of the corresponding Technical Proposal and correct any computational errors). The cost of any unpriced items shall be assumed to be included in other costs in the proposal. In all cases, the total price of the Financial Proposal as submitted shall prevail.

2.9.3 Contract price variation is not allowed.

2.10 **Negotiations**

2.10.1 Negotiations will be held at the same address as “address to send information to the Client” indicated in **Appendix “A”**. The aim is to reach agreement on all points of the contract and to sign a contract.

2.10.2 Negotiations will be based on the Technical Proposal which will include among others, the proposed methodology and work plan, staffing and any suggestions made by the firm to improve the Terms of Reference. kasneb and the firm will then work out final Terms of Reference, staffing and gantt charts indicating activities, staff periods in the field and in the head office, logistics and reporting. The agreed work plan and final Terms of Reference will then be incorporated in the “Description of Services” and form part of the Contract. Special attention will be paid to getting the most the firm can offer within the available budget and clearly defining the inputs required from kasneb to ensure satisfactory implementation of the assignment.

2.10.3 Having selected the firm on the basis of, among other things, an evaluation of proposed key professional staff, kasneb expects to negotiate a contract on the basis of the experts named in the proposal. Before contract negotiations, kasneb will require assurances that the experts will be actually available. kasneb will not consider substitutions during contract negotiations unless both parties agree that undue delay in the selection process makes such substitution unavoidable or that such changes are critical to meet the objectives of the assignment. If this is not the case and if it is established that key staff were offered in the proposal without confirming their availability, the firm may be disqualified.

2.10.4 The negotiations will conclude with a review of the draft form of the Contract. To complete negotiations, kasneb and the selected firm will initial the agreed Contract. If negotiations fail, kasneb will invite the firm whose proposal received the second highest score to negotiate a contract.

2.10.5 kasneb shall appoint a team for the purpose of the negotiations.

2.11 **Award of Contract**

2.11.1 The Contract will be awarded following negotiations. After negotiations are completed, kasneb will promptly notify other Consultants on the shortlist that they were unsuccessful and return the Financial Proposals of those Consultants who did not pass the technical evaluation.

2.11.2 The selected firm is expected to commence the assignment on the date and at the location specified in **Appendix “A”**.

- 2.11.3 The parties to the contract shall have it signed within 30 days from the date of notification of contract award unless there is an administrative review request.
- 2.11.4 kasneb may at any time terminate procurement proceedings before contract award and shall not be liable to any person for the termination.
- 2.11.5 kasneb shall give prompt notice of the termination to the tenderers and on request give its reasons for termination.
- 2.11.6 To qualify for contract awards, the tenderer shall have the following:
- (a) Necessary qualifications, capability and experience to provide the service being procured.
 - (b) Legal capacity to enter into a contract for procurement.
 - (c) Shall not be insolvent, in receivership, bankrupt or in the process of being wound up and is not the subject of legal proceedings relating to the foregoing.
 - (d) Shall not be debarred from participating in public procurement (as evidenced in writing).

2.12 Confidentiality

Information relating to evaluation of proposals and recommendations concerning awards shall not be disclosed to the Consultants who submitted the proposals or to other persons not officially concerned with the process, until the winning firm has been notified that it has been awarded the Contract.

2.13 Corrupt or fraudulent practices

- 2.13.1 kasneb requires that the Consultants observe the highest standards of ethics during the selection and award of the consultancy contract and also during the performance of the assignment. The tenderer shall sign a declaration that he has not been and will not be involved in corrupt or fraudulent practices.
- 2.13.2 kasneb will reject a proposal for award if it determines that the Consultant recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question.
- 2.13.3 Further, a Consultant who is found to have indulged in corrupt or fraudulent practices risks being debarred from participating in public procurement in Kenya.

TERMS OF REFERENCE (TOR) FOR RFP NO. KAS/RFP/MSR/009/2018/2019: PROVISION OF CONSULTANCY SERVICES FOR UNDERTAKING A SURVEY ON VIEWS OF STAKEHOLDERS ON THE MAJOR SYLLABUSES REVIEW

3. BACKGROUND

3.1 Legal foundation

kasneb was inaugurated on 24 July 1969 and operates under the Accountants Act, No. 15 of 2008, the Certified Public Secretaries of Kenya Act, Cap. 534 of 1988 and the Investment and Financial Analysts Act, No.13 of 2015.

3.2 Mandate

The mandate of kasneb, which is derived from Section 17 of the Accountants Act, is the development of syllabuses, conduct of professional, diploma and certificate examinations and certification of candidates in finance, accountancy, governance, management, information technology and related disciplines, promotion of its qualifications nationally and internationally and the accreditation of relevant training institutions in liaison with the ministry in charge of education.

3.4 Vision

Global leader in examination and certification of business professionals.

3.5 Mission

Empowering professionals globally by offering quality examinations and undertaking research and innovation.

3.6 Examinations

kasneb offers professional, diploma and certificate examinations leading to the following qualifications:

(a) Professional qualifications

- (i) Certified Public Accountants (CPA).
- (ii) Certified Secretaries (CS).
- (iii) Certified Information Communication Technologists (CICT).
- (iv) Certified Investment and Financial Analysts (CIFA).
- (v) Certified Credit Professionals (CCP).

(b) Diploma qualifications

- (i) Accounting Technicians Diploma (ATD).
- (ii) Diploma in Information Communication Technology (DICT).
- (iii) Diploma in Credit Management (DCM).

(c) Certificate qualification

Certificate in Accounting and Management Skills (CAMS).

The examinations are administered throughout the Republic of Kenya and in foreign countries through the Kenya High Commissions, Embassies and Consulates. The examinations are offered twice a year in May and November.

3.7 Organisation Structure

An organisation structure details how an organisation categorises and delegates tasks to achieve a specific goal. The organisation structure determines how business decisions are made and implemented at all levels of the business. kasneb is divided into three divisions and six units namely:

- (a) Examinations Division
- (b) Finance Division
- (c) Human Capital and Administration Division
- (d) Information Communication Technology Unit
- (e) Internal Audit and Risk Unit
- (f) Marketing and Communications Unit
- (g) Planning and Strategy Unit
- (h) Supply Chain Management Unit
- (i) Legal and Compliance Unit

Currently, kasneb has one hundred and sixteen (116) members of staff, one hundred and seven (107) based at kasneb Towers, Upper Hill, Nairobi, eight (8) based at select Huduma centres across the country and one (1) based in Kigali, Rwanda.

3.8 CONSULTANCY

3.8.1 Introduction

kasneb is in the process of undertaking a major syllabuses review. One of the key steps in the syllabuses review process is obtaining views of stakeholders. A survey on the views of stakeholders is critical in obtaining stakeholder input into the syllabuses and ensuring that the syllabuses address the needs of the market.

3.8.2 Overall Objective

The overall objective of the consultancy is to undertake a survey of views of the stakeholders of kasneb with the aim of identifying the market needs and priorities for consideration in review of the current examination syllabuses of kasneb and/or developing new examinations.

3.8.3 Research Objectives

- (a) Identify and develop a list of stakeholders through a consultative process with senior management of kasneb.
- (b) Develop an appropriate tool in consultation with senior management of kasneb to be used to conduct interviews with stakeholders.
- (c) Undertake a survey on the views of the stakeholders on:
 - (i) The title and structure of the examinations
 - (ii) The validity of each of the papers (subjects) in the syllabuses in meeting market needs.
 - (iii) The objectives of each paper (subject) in the syllabuses.
 - (iv) The content which should be included in the current syllabuses to make them more relevant.
 - (v) The content which should be removed if considered inappropriate having regard to the current and future market environment.
 - (vi) The logical flow of the content across the papers (subjects) paying particular attention to void overlaps and ambiguities.
 - (vii) The optimal number of papers (subjects) in each syllabus.
 - (viii) New examinations to be introduced, if any
 - (ix) Existing examinations to be passed out, if any.
 - (x) The examination rules and regulations
 - (xi) Any other matters that may improve the examination syllabuses

- (d) Review the existing examination syllabuses and compare the content with the views and suggestions of the stakeholders as per the research objective (c) above.
- (e) Review the examination syllabuses of other national and foreign examination bodies for the purposes of benchmarking.
- (f) Review the relevant laws that govern operations of kasneb.
- (g) Undertake a job analysis in the areas relevant to kasneb qualifications.
- (h) Compile and submit a report on the views of stakeholders on the syllabuses review and existing skills/competencies gaps from the job analysis to be considered during the major syllabuses review.

3.8.4 Specific Tasks

- (a) Review the relevant background materials which will include but not limited to:
 - (i) The ten examination syllabuses.
 - (ii) Corporate Strategic Plan (2012-2017).
 - (iii) Organisation structure, functions and duties.
 - (iv) The service charter.
 - (v) Accountants Act, No. 15 of 2008.
 - (vi) The Certified Public Secretaries of Kenya Act, Cap 534.
 - (vii) State Corporations Act, Cap 446.
 - (viii) The Constitution of Kenya, 2010.
 - (ix) The Examinations Division Policy Manual.
- (b) Obtain the stakeholders' views on:
 - (i) The examination syllabuses of kasneb with regard to the content to be added, deleted, re-organised or retained in order to meet the current and future needs of the market.
 - (ii) Current examination rules, regulations and policies with particular emphasis on changes and improvements required thereon.
- (c) Review the existing examination syllabuses and compare the content with the views and suggestions of the stakeholders as per term of reference (b) above.
- (d) Undertake a job analysis for positions at technician and professional levels in each of the following areas for which kasneb offers qualifications.
 - Financial management, investment and securities analysis.
 - Accounting, auditing and taxation.
 - Governance and company secretarial practice.
 - Information communication technology.
 - Credit management.
- (e) Identify existing and potential gaps in skills and competencies in the current syllabuses from the job analysis in (d) above which should be addressed in the syllabuses review.
- (f) Conduct interviews with the Acting Chief Executive Officer, Directors, Deputy Directors, Heads of Units and Examination Officers to obtain their views on syllabuses review.
- (g) Compile and submit a report on the views of stakeholders on syllabuses review and existing skills/competencies gaps to the Secretary and Chief Executive.

3.8.5 **Scope of Services**

The Consultant will be expected to undertake the following activities:

- (a) Prepare the work plan for the consultancy.
- (b) Identify the stakeholders from whom to obtain views on syllabuses review.
- (c) Develop in consultation with senior management of kasneb an appropriate tool for conducting a survey on stakeholders' views on syllabuses review.
- (d) Conduct interviews with the identified stakeholders.
- (e) Undertake a job analysis in the areas relevant to kasneb qualifications.
- (f) Prepare and submit the draft report of the survey to the Secretary and Chief Executive for review.
- (g) Revise and submit the final report of the survey to the Secretary and Chief Executive.

3.8.6 **Involvement of kasneb members of staff**

The Consultant will be required to involve kasneb members of staff where applicable to ensure skills transfer and buy-in into the process.

3.8.7 **Deliverables**

- (a) An appropriate tool to be used to carry out a survey on views of stakeholders on syllabuses review.
- (b) A report on stakeholders' views and skills/competencies gaps in hard and soft copies in Ms Word format.

3.8.9 **Portfolio of expertise and qualifications**

(a) **The Firm**

The Consultant will be required to demonstrate expertise and skills in undertaking a consultancy of similar nature by providing evidence of similar projects undertaken in the public sector in the last 3 years.

(b) **Academic Qualifications**

Members of the consulting team will be required to demonstrate that they hold individually a minimum of a first degree in social sciences or other relevant disciplines from a recognised university.

Membership of the consulting team must demonstrate that they hold valid membership to a reputable professional body and are in good standing.

(c) **Individual team member's portfolio of experience**

The team leader should have a minimum of seven (7) years experience in undertaking similar consultancies with a demonstrable level of acceptance of the results.

Associates and support Consultants should have a minimum of a degree in relevant disciplines and a minimum of five (5) years experience in undertaking similar consultancies in either the private or public sector.

3.9.10 **Duration of the Consultancy**

The entire assignment including compilation of the report on the stakeholders views on the syllabuses review is estimated to last not more than **thirty (30) days**. The exercise is expected to commence immediately after the award of tender. The Consultant firm will be required to devise appropriate strategies to generate as much information as necessary to accomplish the task **within thirty (30) days of commencement of the consultancy**.

3.9.11 **Proposal Evaluation and Award**

Proposal evaluation and award will be based on the following criteria:

(a) Technical evaluation on the deliverables	- 70%
(b) Financial evaluation on the priced quote	- <u>30%</u>

3.9.12 **Terms of Payment**

The terms of payment for the consultancy will be as follows:

8. **Consultant not to be Engaged in certain Activities**

The Consultant agrees that during the term of this Contract and after its termination the Consultant and any entity affiliated with the Consultant shall be disqualified from providing goods, works or services (other than the Services and any continuation thereof) for any project resulting from or closely related to the Services.

9. **Insurance**

The Consultant will be responsible for taking out any appropriate insurance coverage.

10. **Assignment**

The Consultant shall not assign this Contract or sub-contract any portion of it without the Client's prior written consent.

11. **Law Governing Contract and Language**

The Contract shall be governed by the laws of Kenya and the language of the Contract shall be English Language.

12. **Dispute resolution**

Any dispute arising out of the Contract which cannot be amicably settled between the parties shall be referred by either party to the arbitration and final decision of a person to be agreed between the parties. Failing agreement to concur in the appointment of an Arbitrator, the Arbitrator shall be appointed by the chairperson of the Chartered Institute of Arbitrators, Kenya branch, on the request of the applying party.

13. **Force Majeure**

A. Definition

For the purposes of this Contract, "Force Majeure" means an event which is beyond the reasonable control of a party and which makes a party's performance of its obligations under the Contract impossible or so impractical as to be considered impossible under the circumstances.

B. No Breach of Contract

The failure of a party to fulfill any of its obligations under the Contract shall not be considered to be a breach of, or default under the Contract shall not be considered to be breach of, or default under, this Contract insofar as such inability arises from an event of Force Majeure, provided that the party affected by such an event (a) has taken all reasonable precautions, due care and reasonable alternative measures in order to carry out the terms and conditions of this Contract, and (b) has informed the other Party as soon as possible about the occurrence of such an event.

14. Termination

A. By the Client

The Client may terminate this Contract by not less than thirty (30) days' written notice of termination to the Consultant, to be given after the occurrence of any of the events specified in this clause;

- (a) If the Consultant does not remedy a failure in the performance of his obligations under the Contract within thirty (30) days after being notified or within any further period as the client may have subsequently approved in writing;
- (b) If the Consultant becomes insolvent or bankrupt;
- (c) If, as a result of Force Majeure, the Consultant is unable to perform a material portion of the services for a period of not less than sixty (60) days; or
- (d) If the Consultant, in the judgment of the Client, has engaged in corrupt or fraudulent practices in competing for or in executing the Contract.

For the purposes of this clause;

“Corrupt practice” means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the selection process or in Contract execution.

“Fraudulent practice” means a misrepresentation of facts in order to influence a selection process or the execution of Contract to the detriment of the Client, and included collusive practice among consultants (prior to submission of proposals) designed to establish prices at artificial non-competitive levels and to deprive the Client of the benefits of free and open competition.

- (e) If the Client in his sole discretion decides to terminate this Contract.

B. By the Consultant
